A Brief History of the East Coast Weisels

Introduction

I start this story with a reference and a thank you to Bonnie D. Weisel, a faculty member of the University of Wisconsin and genealogist par excellence who has helped me with my research. Although her website on the Weisel families is no longer on the internet, she has done extensive genealogical research on her family which emigrated from Germany about 120 years after our East Coast Weisel family and settled in the Midwest. No relationship has been shown to exist between the two families.

Our family emigrated from Europe in the days after the reign of Louis XIV, King of France who died in 1715. His armies had swept like a scythe through the Rhineland during the War of the Palatine Succession and at the king's orders, had left scorched earth in their wake. It was hard for ordinary people to make a living in those days. The following excerpt from the Wexford Palatines website may give some indication of the magnitude of this event. [The War of the Palatine Succession has many names. It is most commonly known as The Nine Years War. It is also known as The War of the Grand Alliance or the War of the League of Augsburg. The first serious engagement of the war began when Louis XIV army crossed into the Rhineland in September 1688 laying siege to Philippsburg. After a month long siege Philippsburg fell in October. Following this, the army took many of the key cities in the Palatinate including Mannheim, Worms, Kaiserslautern, Heidelberg, and Mainz. France was now in control of all the Palatinate south of Mainz. This, however, would be as far as Louis XIV would go.

Louis XIV quick sweep through German cities had a galvanizing effect on the German Princes. Fearful of their own states they met in Magdeburg on 22nd October and agreed to mobilize the forces of Germany in a united army. This was an unexpected turn of events and one that Louis had not prepared for. Not willing to fight a protracted war on German soil, Louis decided to retreat. However, in his retreat he made a decision that would have absolutely devastating consequences for the Palatinate.

Louis XIV was worried that the mobilized German army would continue and invade France. To prevent this, Louis XIV implemented $\underline{\text{scorched earth}}$ policy as

the French made their way back to France. All the main cities and towns of the Palatinate where burned to the ground or destroyed. The German forces finally entered the Palatinate in 1689 laying siege to Mainz on the 22nd July. The siege ended on the 8th September when the French surrendered.] I want to take this opportunity to note that the [] insert is used to denote my comments or observations that are not in the original text. Original Settlement

The story of the East Coast Weisel family in North America began with the arrival in Philadelphia of George Michael Weisel and his family which consisted of his wife Susanna [Kiefer?] and either 6 or 7 children. They arrived in colonial Pennsylvania on 17 Oct, 1732 aboard the John and William, a pink (type of sailing ship) that had sailed from Rotterdam to Dover, England and thence from Europe to Philadelphia. (INTR 1) Colonial Pennsylvania was a proprietorship owned by the Penn family of England. It had been established in 1682 by the Quaker, William Penn who had received a grant of land in North America from King Charles II in settlement of debts owed by the king to Penn's father, an admiral in the British navy. William Penn was deceased by the end of July 1718 so our family's business was with his heirs. In 1743, George Michael Weisel purchased the land in Bedminster Township, Bucks County that became his plantation from the Penn heirs. (INTR_2) The deed was signed by Thomas Penn and John Penn. That year was eleven years after the family landed in Pennsylvania. It is likely that they came as redemptioners, that is they had signed a contract to work in return for someone paying their passage. Such contracts of indenture were usually for a period of seven years.

My comments from here on will follow the outline in the report "Ancestry and Descendants of Samuel Weisel (1828-1916) and Katharine Kober Weisel (1829-1914). Samuel was a great-great-grandson of the immigrant George Michael Weisel who was known by the name of Michael Weisel. We know his full name from the entry in the Tohickon Union Church records, page 133 in the bound copy of Church Records of the 17th and 18th Centuries: German Church Records — Volume I by F. Edward Wright where he is recorded at the witness or sponsor for

George Michael Heintz, son of Anthony Heintz and Apollonia Weisel Heintz. (INTR_3). The Tohickon Union Church was two congregations, one German Reformed and the other Lutheran which in the early days shared a building. Of the Weisel baptisms at Tohickon, about two thirds were in the Reformed congregation, one third in the Lutheran.

To my knowledge, there is no record of where the immigrant. Michael Weisel [George Michael Weisel I] by my designation) was born in Europe or from whence he came. I am trying to base this account as much as possible on evidence, not on conjecture. It is not always possible to have direct evidence for all events but it may be possible to deduce certain scenarios from evidence. By reading the 1757 will of Michael Weisel (INTR_4) it is possible to determine some of the family relationships. Jacob Weisel receives his father's plantation but is required to pay his siblings their shares according to a set schedule. The eldest son, believed to be Frederick, is mentioned first but is not named. The next named is the second son, Michael, designated by me as [George Michael II]. He is Samuel Weisel's great grandfather and is our direct ancestral link. The third person mentioned is the eldest daughter, Apollonia. Another son, George Weisel, is the fourth mentioned person. Barbara, another daughter is the fifth mentioned and the last mentioned is Magdalena, a child of Christina, Michael's deceased daughter. By referring to the Tohickon Church records, (INTRO_3 ReDir Page 137) it can be noted that she was baptized in 1751. If Christina were 20 years old the year that Magdalena was born, her birth year would have been 1731 and she would come with the family as an infant. If she were 18 years old, she would have been born in 1733, the year after the family landed. Either scenario would seem to be possible.

1743 Weisel Land Purchase and 1757 Reassignment

Thomas Penn and John Penn Esquires true and absolute proprietaries and governors in chief of the province of Pennsylvania & counties of New Castle, Kent & Sussex on Delaware. To all to whom these presents shall come, Greetings. Whereas John Penn, Thomas Penn & Richard Penn Esquires late proprietaries of the said province by their Patent or Grant dated the Seventeenth Day of February 1743 did for the consideration therein mentioned give, grant, release & confirm unto Michael Wisel his heirs & assigns Two certain tracts of land. One of them situate in Bedminster Township Bucks County & Beginning at a small white oak marker thence by other land of Michael Wisel south west one hundred & fifty perches to a post, thence by vacant land north west one hundred & seventy two perches to a stone, thence by Michael Freilick north east seventy perches to a post, thence by James Kilpatricks land the two xxx & distances next following nigh south east forty four perches to a stone, thence by John Woomans land south east one hundred & twenty eight perches to the place of beginning. Containing one hundred & thirty one acres and allowance of six percent for roads. And the other of them situate on a branch of Perkiomen Creek in the said County & beginning at a marked white oak sapling & extending thence by vacant land south west one hundred & fifty perches to a post thence by vacant land south east one hundred & seventy perches to a post thence by William Allen's land north east one hundred & fifty perches to a post thence by vacant land north west one hundred & seventy perches to the place of beginning, containing one hundred & fifty acres & allowance aforesaid. Together with the appurtenances to hold to him the said Michael Wisel his heirs & Assigns forever as by the said patent records at Philadelphia in Patent Book AA vol 13 page 369 more fully appears. And Whereas the said Michael Wisel did on the eighteenth day of February 1743 for the better securing the payment of the consideration in the said patent mentioned with the interest then thereon due, mortgage the said tracts of land unto the said proprietaries which said sum of money and the interest thereon due hath been since fully satisfied & discharged by the said Michael Wisel as appears by Lynford Gardners the then Receiver General's receipt endorsed on the said receipt mortgage and whereas the said Michael Wisel & Susanna his wife by their deed dated the tenth day of February 1757 did for the consideration therein mentioned grant & convey the said tracts of land with their appurtenances unto their son Jacob Wisel of Bedminster Township aforesaid Yeoman to hold to him his heirs & assigns forever. And Whereas the said Jacob Wisel hath now represented to us that the said Michael Wisel

was an alien born out of the Dominion & Allegiance of his Britannic Majesty at the time of our granting to him the said letters patent and that the said Jacob Wisel is a native of this province and hath therefore humbly besought us to release and confirm to him all the estate rights and title which hath, may or can accrue to us, our heirs and successors in or to the said two above described tracts of land by reason of the said Michael Wisel's being an alien as aforesaid and we being desirous on all occasions to show our willingness and reasonableness to encourage the cultivation and improvement of our said province and to favor the settlers thereof, have graciously condescended & agreed to release & relinquish such advantages as hath, can or may accrue to us, our heirs or successors thereby and fully to grant the said petitioner's request. Now therefore know ye that for and in consideration of the premium and of the sum of Five Shillings lawful money of our said province to our use paid by the said Jacob Wisel (the script whereof we hereby acknowledge) and of the yearly quit rents as before and herein reserved and capesfsied?, we have granted, released, remised, relinquished, quit claimed and confirm unto the said Jacob Wisel his heirs & assigns all the estate rights, titles, interest, property claim and demand whatever, both at law and in equity which hath, may or can accrue or appertain to us, our heirs or successors in or to the said two above described tracts of land by reason or means or on account of the said Michael Wisel's being an alien as aforesaid or anything relating thereto. To hold unto the said Jacob Wisel his heirs and assigns to and for the proper use and behoof of the said Jacob Wisel his heirs and Assigns forever under and subject and yielding and paying nevertheless unto us, our heirs and successors at or upon the first day of March in every year forever at our manor of Pennsbury in the said county one half penny sterling for every acre of the same or value thereof in coin current to such person or persons as shall from time to time be appointed to receive the same. Witness Richard Penn Esquire Lieutenant Governor or the said province who by virtue of certain powers and authorities to him for this purpose inlocalia granted by the said proprietaries hath hereunto set his hand and caused the Great Seal of the said province to be hereunto affixed at Philadelphia this seventeenth day of September in the year of our lord one thousand seven hundred and seventy two and in the twelfth year of the reign of King George the Third over Great Britain.

First Generation

The original Weisel family consisted of George Michael I, his wife, Susanna, and four boys and three girls with the oldest children being Frederick, Apollonia and Barbara. Along with their parents, these three were of adult age (most likely 16 and over) and took the oaths of Allegiance and Abjuration (FSTGEN_1) upon their arrival in Philadelphia. According to the Tohickon Church records, our ancestor, George Michael II died in 1796 at the age of 76 years (INTRO_3 ReDir page 205), making his birth year about 1720. He would have been a boy of twelve when he arrived in Philadelphia. His brother, Jacob, who was given the family plantation by his father's 1757 will, died in 1797 at the age of 72 years, making his birth year about 1725. He would have been a boy of seven when the family landed. George, the remaining male child is unaccounted for by age. He is listed in the church records as having died in 1802 but his age at death was not given so it is not possible to place him in a birth order by age. The will stipulates that Christina was the youngest daughter.

By way of background, the colonial authorities in Pennsylvania required all foreigners to take these oaths. The Glorious Revolution (1688-1689) had taken place in Britain during the course of which the Stuart king, James II went into exile in France. The last Stuart monarch, Queen Anne, died in 1714 without an heir and the Elector of Hanover, Germany became king of England as King George I of the House of Hanover. There had been a Jacobite uprising in Britain in 1715 where James' son (the Old Pretender) attempted to reclaim the throne for the Stuart line. This failed but another attempt was made in 1746 by Bonnie Prince Charlie (the Young Pretender) which also failed. The Weisel family emigrated from Europe in between these two political events. But as a result of the Jacobite uprisings, the colonial authorities were keen to prevent Jacobite sentiment from taking root in the colonies. While this precaution was the main reason for administering the Oaths of Allegiance and Abjuration (FSTGEN_2), it had the effect of giving us some additional information about the Weisel family.

OATHS OF ALLEGIANCE AND ABJURATION

On September 14, 1727, Patrick Gordon, the Lieutenant Governor of the Province of Pennsylvania, called together the Provincial Council, and "acquainted the board, that he had called them together at this time to inform them that there is lately arrived from Holland, a ship with four hundred Palatines, as 'tis said, and that he has information they will be followed by a much greater Number, who design to settle in the back parts of this province; & as they transport themselves without any leave obtained from the Crown of Great Britain, and settle themselves upon the Proprietors untaken up Lands without any application to the Proprietor or his Commissioners of property, or to the Government in general, it would be highly necessary to concert proper measures for the peace and security of the province, which my be endangered by such numbers of Strangers daily poured in, who being ignorant of our Language & Laws, & settling in a body together, make as it were, a distinct people from his Majesties Subjects.

"The Board taking the same into their serious consideration, observe, that as these People pretended at first that they fly hither on the Score of their religious liberties, and come under the protection of His Majesty, it's requisite that in the first Place they should take the Oath of Allegiance, or some equivalent to it to His Majesty, and promise Fidelity to the Proprietor & obedience to our Established Constitution; And therefore, until some proper Remedy can be had from Home, to prevent the Importation of such numbers of Strangers int this or others of his Majesties Colonies.

"'TIS ORDERED, that the Masters of the Vessells importing them shall be examined whether they have any leave granted them by the Court of Britain for the Importation of these Foreigners, and that a List shall be taken of the Names of all these People, their several Occupations, and the Places from whence they come, and shall be further examined touching their intentions in coming hither; And further, that a Writing be drawn up for them to sign declaring their Allegiance & Subjection to the King of Great Britain & Fidelity to the Proprietary of this Province, & that they will demean themselves peaceably towards all his Majesties Subjects, & strictly observe, and conform to the Laws of England and of the Government.

"At a Council held at the Courthouse of Philadelphia, September 21st, 1727. Present:

"The Honorable Patrick Gordon, Esq., Lieutenant Governor.

James Logan, William Fishbourn } Esq'rs. Richard Hill

"A Paper being drawn up to be signed by those Palatines, who should come into this Province with an Intention to settle therein, pursuant to the order of this Board, was this day presented, read & approved, & is in these Words:

"We Subscribers, Natives and Late Inhabitants of the Palatinate upon the Rhine & Places adjacent, having transported ourselves and Families into this Province of Pennsylvania, a Colony subject to the Crown of Great Britain, in hopes and Expectation of finding a Retreat & peaceable Settlement therein, Do Solemnly promise & Engage, that We will be faithful & bear true allegiance to his present MAJESTY KING GEORGE THE SECOND, AND HIS Successors, Kings of Great Britain, and will be faithful to the Proprietor of this Province; And that we will demean ourselves peaceably to all His said Majesties Subjects, and strictly observe & conform to the Laws of England and of this Province, to the utmost of our Power and best of our understanding."

This declaration of allegiance is found at the head of all the papers, bearing the signatures of immigrants, marked B in the following pages. Beginning with August 19, 1729, the immigrants were required to sign two additional declarations, which were entered in a bound book. The latter in course of time became a series of bound books, to each of which these two declarations were prefixed. The signatures to these declarations are marked C in the following pages.

The two additional declarations, to which the immigrants affixed their signatures in the bound books, were as follows: "I A B do solemnly & sincerely promise & declare that I will be true & faithful to King George the Second and do solemnly sincerely and truly Profess Testify & Declare that I do from my Heart abhor, detest & renounce as impious & heretical that wicked Doctrine & Position that Princes Excommunicated or deprived by the Pope or any Authority of the See of Rome may be deposed or murthered by their Subjects or any other whatsoever. And I do declare that no Foreign Prince Person Prelate State or Potentate hat or ought to have any Power Jurisdiction Superiority Preeminence or Authority Ecclesiastical or Spiritual within the Realm of Great Britain or the Dominions thereunto belonging.

"I A B do solemnly sincerely and truly acknowledge profess testify & declare that King George the Second is lawful & rightful King of the Realm of Great Britain & of all others his Dominions & Countries thereunto belonging, And I do solemnly & sincerely declare that I do believe the Person pretending to be Prince of Wales during the Life of the late King James and since his Decease pretending to be & taking upon himself the Stile & Title of King of England by the Name of James the third, or of Scotland by the Name of James the Eighth or the Stile & Title of King of Great Britain hath not any Right or Title whatsoever to the Crown of the Realm of Great Britain, nor any other the Dominions thereunto belonging. And I do renounce & refuse any Allegiance or obedience to him & do solemnly promise that I will be true and faithful & bear true allegiance to King George the Second & to him will be faithful against all traitorous Conspiracies & attempts whatsoever which shall be made against his Person Crown & Dignity & I will do my best Endeavors to disclose & make known to King George the Second & his Successors all Treasons and traitorous Conspiracies which I shall Know to be made against him or any of them. And I will be true & faithful to the Succession of the Crown against him the said James & all other Persons whatsoever as the same is & stands settled by An Act Entitled An Act declaring the Rights & Liberties of the Subject & settling the Succession of the Crown to the late Queen Anne & the Heirs of her body being Protestants, and as the same by one other Act Entitled An Act for the further Limitation of the Crown & better securing the Rights & Liberties of the subject is & stands settled & entailed after the Decease of the said late Queen & for Default of Issue of the said late Queen, to the late Princess Sophia Electoress & Duchess Dowager of Hannover & the Heirs of here Body being Protestants; and all these things I do plainly & sincerely acknowledge promise & declare according to the plain & common Sense and understanding of the same Words, without any Equivocation mental Evasion or secret Reservation whatsoever. And I do make this Recognition Acknowledgment Renunciation & Promise heartily willingly & truly.

1757 Will of [George] Michael Weissel

I, Michael Weisel being at this time sick and weak but yet of sound understanding do hereby make my testament or last will in the words following: First it is my will that after my decease my heirs bury me in a Christian like manner and my soul I commend to the Lord God. Secondly, it is my will that all the movable goods wherewith God has blessed me shall be of my wife Susanna and she shall keep the same in her hands during her life and do therewith as she pleases and she shall have her living in the house where we now dwell agreeable to the contract made between myself and my son Jacob Wysel. Thirdly it is my will that all my children so as they are herein mentioned shall have their hereditary shares in manner following: first my son Jacob Weisel shall have my plantation and for the same he shall give to his brothers and sisters their hereditary shares, first to my eldest son 50 pounds in May Fair to wit, the 27th of May 1758 he shall give him 25 pounds and the 27th of May 1759 again 25 pounds which shall be his full hereditary share. Then to my second son Michael he shall give the 27th of May 1760 25 pounds and the 27th of May 1761 again 25 pounds which shall be his full hereditary share. Thirdly, to my eldest daughter Abolonia I do bequeath her hereditary portion as followeth to wit my son Jacob Weisel shall 1768 May 27th pay unto George Heintz the son of Andorry Heintz 25 pounds which shall be divided in equal parts among the children of Andorry Heintz and it is my will that my daughter Abolonia shall have in money one shilling sterling to be paid her by Jacob Weisel on the 27th of May 1769 which shall be her hereditary portion. Fourthly my son Jacob Weisel shall give to his brother George Weisel 50 pounds in two equal payments, the first payment to be made the 27th of May 1764 to wit 25 pounds and on the 27th of May 1765 again 25 pounds which shall be his hereditary share. Fifthly my daughter Barbara shall have 50 pounds in two equal payments 1766 the 27th of May she shall have 25 pounds and 1767 the 27th of May again 25 pounds which shall be her hereditary portion. Sixthly the child of my deceased daughter left behind her now living with her father George Wildanger, her name is Magdalena, shall instead of my youngest daughter deceased, have her hereditary portion of 50 pounds which money has been fully paid to George Wildanger and he, George Wildanger shall pay that 50 pounds to that child in two payments, on the 27th day of November 1770 he shall pay 25 pounds to that child and 1771 again 25 pounds which shall be the child's hereditary portion and it is my will that my son Michael Weisel shall be the guardian of the above named child and have in his keeping until she cometh to age the bonds belonging to that child and given for the use of the said child by her father George Wildanger which is my will wrote by me Michael Weisel and sealed and signed the 3rd of October in the year 1757.

Louis Weiss of the city of Philadelphia, a scrivener, maketh oath that the foregoing is a true translation of an original writing in the German language purporting to be the last will and

testament of Michael Weisel deceased now remaining in the Register General Office at Philadelphia and that from the same original he the deponent has made and therewith compared the said translation as further saith not.

The Second Generation

All of the second generation, with the possible exception of Christina, were born in Europe and came with the family to British North America. The history of this generation should be viewed with the fact in mind that very little is known of Frederick, the eldest son. His name is mentioned only once in the Tohickon church records and that is connection with the death of his child in 1758. He apparently was not married in the church and none of his children were baptized at Tohickon. The number of his children is unknown. He did take the oath of citizenship and become a naturalized citizen using the Moravian sacrament of not swearing an oath. (SECGEN_1) The fact that he was a naturalized citizen using the Moravian sacrament suggests that he may have married a woman from a Moravian or Mennonite family.

The eldest daughter, Appolonia, married Anthony (Hens) Heintz and they had two sons who were baptized at Tohickon before the family left Pennsylvania and relocated to Baltimore, Maryland. Appolonia was essentially disinherited by her father and he left his grandchildren only a half share of his estate. The reason for this action in not known.

The second daughter, Maria Barbara, married Fredrick Sallade (Solliday), who was a descendant of a family that had emigrated from Switzerland. According to an account by William Davis titled "A Genealogical and Personal History of Bucks County, Pennsylvania", Frederick Solliday was a clockmaker. A number of their children were baptized at Tohickon.

The second son is Michael [designated by me as George Michael II] and he is our direct ancestor. He married Maria Magdalena [Trach?] and they had eight children of which seven (four boys and three girls) appear to have survived to become adults. The names of these children are shown on the Schedule titled

Children of George Michael II and Magdalena Weisel (SECGEN_2). There is confusion about George Michael II. There should not be however, if one considers the 1783 tax roll for Bedminster Township that is on file at the Spruance Library in Doylestown, PA (SECGEN_3). This tax roll lists Michael Sr. and Michael Jr. as landowners. Michael Sr. cannot be the immigrant, my supposition is that Michael Sr. is [George Michael II, b. abt. 1720 in Europe] while Michael Jr. is [George Michael III, b. 1750 in Pennsylvania]. This supposition is in accord with data in the Militia records of 1780-1781. The 1796 will of George Michael II [Michael Sr.] lists by name only the heirs to his property, i.e. Michael [George Michael III], Henry [John Henry] and George [George Ludwig] but not John (SECGEN_4)

Jacob Weisel was the designated heir to the plantation of immigrant George Michael I. One reason for this arrangement could have been that Jacob had also become a naturalized citizen and his father was anxious to protect the family landholding from usurpation as much as possible. Jacob's naturalization record is not as clear cut as that of Frederick since it is recorded twice with the surnames misspelled. However, it should be noted that he also took the oath using the Moravian sacrament which may mean that the Weisel family's indenture may have been held by a Mennonite which may have influenced the actions of both Frederick and Jacob. (SECGEN_5) He married Anna Margaret [Schist?] and they had seven children. Their names and birth information are shown in the schedule titled Biographical Information on Children of Jacob and Anna Margaret Weisel of Bedminster Township, Bucks, County, PA (SECGEN_6). Jacob and Margaret's children were peripatetic, three of their sons went to Maryland, although not all at the same time. Daniel went first, he is listed in the 1790 U.S. Census for Washington County, Maryland under the name of Daniel Wysel. In the early days, Daniel was a tanner of leather. From the Bucks County court records, we know that his brother, Jacob, was a shoemaker (cobbler). (SECGEN_7) It is believed that another brother, John (SECGEN_8), had the same occupation and that the two followed their brother, Daniel, to Maryland. For additional information about the Maryland Weisels, please see the piece titled History of the Maryland Weisels excerpted from the 1936 program of the Weisel Family Reunion. (SECGEN_9) The information is not attributed but is believed to have been written by Calvin Kephart. Two other sons, Frederick and George left Bucks County in the early

1800s and settled in Lycoming County, PA near present day Williamsport. Jacob died without a will, Letters of Administration for his estate mention only three of his sons, Frederick, George and Daniel who was living in Maryland. (SECGEN_10)

George Weisel married Anna Maria [Weirbach?] and relocated from Bedminster Township to Richland Township, Bucks County. They had a total of eight children, all of whom were baptized in the Tohickon church (SECGEN_11). This branch is a complicated family story which can be deduced from reading the statement Migration of the Weisel Family of Richland Township (SECGEN_12). Of the five boys, four of them migrated from Bucks County to Bedford County in south central Pennsylvania. The absence of three of the five sons is reflected in the 1798 will of George Weisel. (SECGEN_13). His wife had predeceased him and he divides his plantation between Joseph and Peter. Joseph, the fifth son, stayed in Bucks County but died young. His 1827 will leaves his estate to his wife, Catherine and their children. (SECGEN_14) Peter was still living in Bucks County at the time but later joined his brothers in Bedford County. George died in 1802 but unfortunately, the church records do not give his age at death. The history of this family is comingled with our own, the line of John Weisel, son of George Michael II and Magdalena who migrated from Bucks to Bedford County before 1800. The Bedford County tax roll for 1795 on file at the Bedford County Historical Society lists George Weisel and John Weisel as married men, with Jacob Weisel as a single man. This John Weisel cannot be John Weisel of Richland Township as he was not yet married. His marriage to Margaret Schneider in 1796 is listed in the Tohickon Church records (INTRO_3 ReDir page 199). Some additional notes giving some of the reasoning behind the above story are shown in History of the Weisel Family of Richland Township. (SECGEN 15)

Christina, the youngest child, married George Wildanger and had one child, a daughter named Magdalena (INTRO_3 ReDir page 137). Christina predeceased her father but George Michael I took special care of his granddaughter by giving her a full share of his estate and setting his son, Michael Weisel, as guardian with instructions that she was to receive her share when she became of age. Magdalena married after reaching adulthood.

Michael Weissel's will of 1796 divides his estate between his sons, Michael, Henry and George. The will unfortunately does not mention the name of his wife, his son, John Weisel or any of his daughters. Based on the Augustus Evangelical Lutheran Church records, Michael Weissel, Sr. and Magdalena are parents of four sons instead of just the two that my father's diagram shows. Jorg Michael [Jr.] was baptized in October of 1750 (1) in Trappe, PA.

The Tohickon records show a child of Michael Weisel having died in 1758. There is no record elsewhere of a John Weisel. It appears that the child could have been either Maria Catherine or Veronica but it could not have been John or any of the children born after 1758. Based on recent information, it could not have been Mary Elizabeth because she married Philip Steaver [Stiever] of Haycock Township and in 1807 she petitions the court to appoint her son, Peter Steever, and her brother, Henry, to administer her husband's estate. Steiver served as a militia soldier during the Revolutionary War.

The name Henry doesn't show up at all in the Tohickon Church baptismal records. Could the John Weisel b. 1767 in reality be John Henry Weisel? No, recent evidence exists that John Weisel b. 1767 removed to Bedford County prior to 1800 and died there in 1844. But there are three places where records of a Henry Weisel exist. First, the Pennsylvania Archives show a Hanry Weisel serving in Captain McHenry's company. Secondly, there are a number of baptisms for children of Henry Weisel and his wife, Eva in the church records. Finally, there is a Henry Weisel buried in the Tohickon Union Cemetery. The inscription on his tombstone reads 6 Apr, 1760 - 26 May, 1830 and has a Revolutionary War marker (2).

1796 Will of [George] Michael Weisel II, a.k.a. Michael, Sr.

In the name of God Amen I Michael Weissel of he township of Bedminster & County of Bucks being weak in body but of sound and perfect mind & memory blessed be Almighty God for the same do make and publish this my last will & testament in manner and form following (that is to say) First I give and devise to my son George Weissel his heirs and assigns my plantation I now live on with part of a lot or tract of meadow ground containing ten acres adjoining to my sons Henry's plantation, the said lot to be divided by a straight line from the one side to the other and to cross the creek at a certain log that is over said creek, he, my son George, to have the under part that joins the great road, the other part I give and devise to my son Henry, his heirs and assigns and I do order that my two sons Henry and George shall have the land I have so given and devised to each of them at the sum of five pounds per acre. Also I give and devise to my two sons Michael Weissel and George Weissel their heirs and assigns a piece or tract of land I have adjoining Jacob Houbers land & Henry Silvense's and containing about twenty five acres share and share alike in said land. Each of my said two sons Michael and George to pay the sum of five pounds for said tract & no more and as I have a small lot of land lying between my son Michael Weissel's plantation and my son Henry's plantation, it is my will and I do order that the same be & remain in common for the benefit of water for their cattle. Also it is my will and I do order that my widow shall be and remain on my place where I now live after my decease and to have the use of my house and all my household furniture during the term of her natural life and after her decease, that the same be sold to together with the remainder of my personal estate to the best advantage. And further it is my will and I do order for the support and maintenance of my widow that my son George his heirs and assigns shall give her yearly ten bushels of rye, four bushels of wheat, two bushels of Indian corn and one hundred weight of beef and one hundred weight of porke and shall also keep two cowes for her use both summer and winter with his own cattle and shall also cut and haul home her firewood yearly and plow and sowe a quarter of an acre of flax ground and further I do order that my son George Weissel shall pay for the land and plantation which I have given and devised to him in manner following that to say the sum of fifty pounds part thereof at the end of one year after my decease and on fifty pounds per year until the whole is paid and also my son Henry Weissel shall pay the amount of his part of the meadow ground to him given as before mentioned in one year after my decease and also my son Michael and my son George shall pay the amount of the lot of wood land which I have given to them at the end of one year after my decease. And further it is my will and I do order that my sons Michael, Henry and George shall have equal shares with the rest of my children out of the money arising out of my real and personal estate and each of my children shall have equal share and share alike in the whole of my estate.

And lastly I do hereby constitute my son Michael Weissel and my son Henry Weissel executors of this my last will and testament, hereby revoking all former wills by me made. In witness thereof I have hereunto set my hand and seal this third day of June in the year of our Lord one thousand seven hundred and ninety six.

Signed sealed published and declared by the named Michael Weissel to be his last will and testament in the presence of us who have hereunto subscribed our names and witnesses in the presence of the testator.

Commentary: This entry is believed to be Jacob Weisel since we know by the transfer of land from George Michael Weisel to Jacob that the son was a naturalized citizen at the time of the transfer in 1757. Jacob would have been 24 years of age. The County matches where Jacob would have been resident in 1749 and was about one year before his marriage to Anna Margaret [Shist?]. Their first child, a son, Frederick, was born in 1751. I thought I remembered this name being listed as Weisle but it is shown as noted above in this file. I haven't checked the Archives reference to see which is correct. One comes across various spellings for our family name in different places.

The reason for Jacob to affirm instead of swearing the oath is more problematic than is the case for Frederick. It is possible that the Weisel family indenture was bought by either a Quaker or Mennonite landowner and the Weisel family became imprinted with their indenture holder's philosophy toward oath taking. This seems plausible since neither George Michael or Frederick had any scruples about taking the Oaths of Allegiance [to King George II] and Abjuration when they arrived in Philadelphia in 1732...

Commentary: This entry, the site of which could be either present day Philadelphia or Montgomery county, may be the least likely to represent Jacob Weisel. The site does not correlate with Jacob's probable place of residence in 1743 since his father, George Michael Weisel, purchased his plantation in Bedminster Township, Bucks County in February of 1743. But if the family were living in Philadelphia County in1743, it is possible that Jacob took an oath of citizenship in that place and later decided to take the oath a second time in Bucks County before his marriage. If he did so, the above information would indicate he would have been a young man 18 years of age in 1743. This would have been unusual foresight on his part or perhaps parental influence to ensure that at least one member of the family was a naturalized citizen.

It is known from the deed transferring the land in February of 1757 from his father, George Michael, to Jacob that Jacob, by that time, was a "native" or naturalized citizen. Since this was more than a decade before his death, George Michael evidently believed that in order to protect his family's right to the property, it needed to registered in the name of a person who was a citizen of Pennsylvania, hence the decision to give the land to Jacob with legally enforceable obligations which would protect the estate rights of his other children who received monetary compensation instead of property.

Commentary: It is known that Jacob and Daniel went to Washington County Maryland and died there. Frederick and George both went to live in Lycoming County, Pennsylvania and it may be that John Weisel joined them in Pennsylvania after his brother Jacob died in 1812.

Commentary: The family described in this 1810 census was headed by a male over 45 years of age. John Weisel, son of Jacob and Margaret Weisel was born July 6, 1758 (1) which would make him 52 years of age in 1810. He could be our John Weisel. According to the Washington County Register of Wills, this person did not leave an estate in Washington County, Maryland.

The following is a transcript of part of the 1936 Weisel Reunion [not Descendants of Samuel and Catherine but the Weisel Association Reunion] which contained this history of the Maryland Weisel's. This information may have been prepared by Calvin Kephart.

History of the Maryland Weisels

Brief mention has been made at earlier reunions of the Maryland branch of the Weisel family of Bucks County. It is now fitting that some of the facts of this illustrious group should be made known.

Jacob Weisel, Sr., son of the colonial pioneers, born about 1726, married Anna Margaret _____ (surname not known) early in 1750 and they had the following children:

- (1) Frederick, born January 1, 1751, died unmarried? [Where did Jacob Weisel. b. 1802 come from?] at Williamsport, PA on November 1, 1838;
- (2) Jacob, Jr., born August 5, 1753; more later
- (3) Anna Catherine, born March 18, 1756, died August 18, 1758;
- (4) John born July 6, 1758; no further data;
- (5) George, born January 29, 1761; married Elizabeth Hoenig (Haney) January 18, 1788, born March 18, 1760, died March 8, 1853; descendants around Williamsport, PA;
 - (6) Henry (?); uncertainty as to this name
 - (7) Daniel, born April 10, 1765; more later;
 - (8) Maria Elizabeth, born July 9, 1769, died September 14, 1840, unmarried, at Williamsport, PA.

In our struggle for independence, Jacob, Sr. served as an ensign and First Lieutenant and Frederick as a private in the Bucks County militia and Jacob, Jr. served as a gunner in Captain Joseph Watkins' 1st Company, Artillery Battalion, of Philadelphia. [Thus far it has been confirmed only that Frederick Weisel and George Weisel b. 1761served in the Bedminster Township unit of the Bucks County militia.] In 1786 the brothers Jacob, Jr. and Daniel migrated to the later-named Williamsport, MD, southwest of Hagerstown. Jacob, Jr. died unmarried on October 31, 1812 and was buried there. Daniel associated himself with a Mr. Humrichhouse in the merchandise business there and about 1790 married Margaret Startzman, born September 16, 1773, died July 28, 1817, daughter of Henry and Eve Startzman. Their house was one of the first to be erected on the banks of the Potomac River in that region.

Daniel Weisel, Jr. was graduated from Princeton College in 1824 and immediately entered the office of Attorney Hoffman at Baltimore. While there he was graduated from the Baltimore Law School. In 1826 he was admitted to the Maryland Bar and the same year married Matilda, daughter of Amos and Sarah Teresa (Williams) Davis, the latter a niece of General Otho Holland Williams. [In "Marriages of Washington County, MD 1799-1830", compiled by Dale W. Morrow, records a marriage of Weisel (Weisell) Daniel/Matilda Davis 10/16/1827, Minister: Kellar] In 1830, with a Mr. Tice, he established the "Republican Banner", a Whig newspaper, at Williamsport. His editorials were so able and forcible as to attract widespread attention, including the publishers of the "National Intelligencer". In 1838 they moved to Hagerstown, where he gained a lucrative law practice. From 1847 to 1852 he was Associate Justice of the Judicial District comprising Frederick, Washington, and Allegheny Counties, when by a constitutional change the court was supplanted by the single judge system. In 1861 he was elected Judge of the 6th Judicial Circuit, comprising Washington and Allegheny Counties, and in 1864 he became a judge of the Court of Appeals of the state, going out of office with another constitutional change in the judicial system in 1867. He thereupon resumed private practice.

In 1868 he was Republican candidate for Congress in the 6th District, reducing the normal opposition majority from 2800 to 480. That year he was awarded the honorary degree of L.L.D. by his alma mater, Princeton College. In 1872 he was Delegate-at-large from Maryland to the National Republican Convention that nominated Grant and Wilson.

Judge Weisel was a founder of the Williamsport Bank and its president for many years. His benefactions were numerous and he was an ardent advocate of education. He participated in the promotion and

First I order and direct that all my just debts and funeral expenses be [illegible] paid.

Item: I give and bequeath all my wearing apparel unto my two sons John and Michael to be equally divided between them.

Item: I give and bequeath to my beloved wife, Catherine, a feather bed bedstead and sufficient bedclothes for the winter season, case of drawers, table she brought with her and four chairs to be at her own disposal and also a milch cow and two hogs[?]

Item: It is my will that there shall be sufficient bread, corn and meat if there is sufficient on hand left for the use of my family for six months after my decease.

Item: It is my will and I order and direct my executors herein after named to sell at publick or private sale all my lands and [illegible] with the buildings and appurtenances to the highest and best bidder and also all my personal estate which is not herein before [illegible] as soon as may be the most convenient time after my decease, hereby authorizing and empowering my executor hereinafter named to make and execute a good and lawful deed or title to the purchase of my plantation.

Item: It is my will that after all my just debts are paid that all the remainder of my estate shall be divided as follows:

Item: One third part thereof I give and bequeath unto my beloved wife, Catherine, during the time she remains my widow which said one third shall be put on interest and the interest paid unto her yearly during the time aforesaid.

Item: It is my will and I give and bequeath the remaining two thirds of my estate unto all my children to be equally divided between them share and share alike or their heirs.

Item: It is my will that after the decease or marriage of my beloved wife, the said one third herein before left for her use shall be equally divided between all my children or their heirs.

Item: Whereas my brother Peter has left me to collect his rents which said rent is locked up with his other papers in my possession which I direct shall not be taken account of in the inventory at my decease but given up to him when called for.

Lastly I nominate, constitute and appoint my beloved wife, Catherine, and my brother-in-law Henry Heller to be my executors of this my last will and testament. In witness thereof, I said Joseph Wisel, have hereunto set my hand and seal this twenty fourth day of April in the year of our Lord, One thousand Seven hundred and Twenty Seven.

History of the Weisel Family of Richland Township

This family had a penchant for baptizing their sons with the name "John". For confirmation, see the information below which is taken from Tohickon Church records and the inferences are believed to be correct as of December 12, 2005.

It seems more likely that this John Weisel is really John [Joseph] Weisel, the son of George Weisel and wife whose birth is the above record at the Tohickon Union church:

The 1827 will of a Joseph Weisel indicates provisions for minor children. In addition, the Bucks County Orphans Court records indicate that a will for Joseph Weisel was probated in 1828. [This would indicate an age of 43 years at time of death.]

It is possible that there is also a John Jacob scenario. Unfortunately there is no birth record of a Jacob Weisel at Tohickon but we know from the 1838 Bucks County Orphans Court will abstracts that in 1838, a Jacob Weisel was named along with siblings: George Weisel, John Weisel and Peter Weisel, all living in Bedford County. Joseph Weisel was deceased by this time as noted in the court records. He was the only one of the male children of George and Anna Maria Weisel who remained in Richland Township. Peter did not migrate with his brothers but eventually relocated to Bedford County and died there. Remaining in Richland Township was:

Third Generation

All members of third generation Weisels were born in North America. At this point, I am narrowing the scope of the family history to just our immediate ancestral line stemming from George Michael II and Magdalen. All of their eight children were born before 1776 and were British citizens prior to the Revolutionary War. (SECGEN 2 ReDir). The last child, Maria Magdalena, (b. 23 Jun., 1776 bp. 11 Aug., 1776) just made it before independence from Britain was declared. Their first born was Jurg [Jorg] Michael Weisel, designated by me as George Michael III, also known as Michael Jr. who was born in 1750 and baptized 16 April, 1751 in the Augustus Evangelical Lutheran Church, New Providence Township, Pennsylvania with his father, Jurg [Jorg] Michael [designated as George Michael II by me] as witness. (THRGEN_1). At that time, New Providence Township would have been part of Philadelphia County as Montgomery County where it now lies, was not set off until 1784. The reason for using the Augustus Lutheran Church for the baptism is unknown as the family attended the Tohickon Union Church. George Michael III was married twice, first to Catherine [Gere?] and they had several children before her death. In 1794, in the Tohickon Church, he married Maria Habach, a widow with a minor son, Henry Habach. (INTRO 3 ReDir Page 199). The records of the Bucks County court states that Michael was named guardian of Henry Habach (THRGEN_2). He and Maria had several children of their own. He removed from Bedminster Township to Tinicum Township, Bucks County by about 1800 (THRGEN_3). His 1818 will names his heirs but does not distinguish between the children of his first marriage with Catherine and those with his marriage of Maria (Mary). (THRGEN_4) This makes it difficult to sort out his descendants via the female linage. We do know that one of his sons, Michael G. Weisel was living in New York State. (SECGEN_7 ReDir Page 153). George Michael III died 1818 in Tinicum Township, Bucks County and is buried along with his wife, Mary, in the Tinicum church cemetery. His grave was decorated with a Revolutionary War marker. (THRGEN 5)

Maria (Mary) Elizabeth Weisel was born in 1753 and was the second wife of Philip Stieber, a militia soldier and Revolutionary War veteran. They were married in April, 1774 in the Lutheran congregation at Keller's Church (THRGEN_6). Philip and Maria had children, Philip also had children from his first wife. Maria is the only one of the daughters about which anything is known with certainty. In 1807, Elizabeth Weisel petitioned the Bucks County court to have her son Peter Steever and her brother Henry Weisel act as administrators for estate of her late husband Philip Steever. (THRGEN_7).

Next was Maria Catherine born 1755, followed by Veronica born in 1758. The Tohickon records show a child [most likely a girl as a boy was usually designated as son] of Michael Weisel having died in 1758. It appears this child could have been either Maria Catherine or Veronica but it could not have been John or any of the children born after 1758. I was not able to find any marriage records for either of these women.

John Henry Weisel who went by the name of Henry does not have any record of his baptism at Tohickon. But the History of Tohickon Church lists a baptism where he and his wife were witnesses and gives his full name. (THRGEN_8). The information presented here is from his tombstone at Tohickon and from his death notice in the Bucks County Intelligencer records (THRGEN_9 and 10). The inscription reads that he was born 6 April, 1760 and he died 26 May, 1830. He has a Revolutionary War maker on his grave. This fact makes it an appropriate time to consider the Revolutionary war service of the Weisel family. The history of this service is contained in the Pennsylvania Archives which lists militia soldiers of Captain William McHenry's company in Bedminster Township, Bucks County (THRGEN 11). Frederick Wisel, Mikel Wisel Jr., Hanry Wisel and George Wisel are shown as part of the militia unit. The first and last (Frederick and George) are the sons of Jacob Weisel (Second Generation) while Mikel Jr. and Hanry are sons of George Michael II (Second Generation). Frederick and George left Bucks County to take up residence in Lycoming County about 1805. John Weisel, George and Elizabeth's son was baptized at Tohickon in 1805 as recorded in History of Tohickon Church by William John Hinke. The family moved shortly afterward as

they are shown in the 1810 Census for Lycoming County. (THRGEN_12) Michael Jr. left Bedminster Township about the same time but he only went to Tinicum Township, still in Bucks County. (THRGEN_3 REDir). Henry is only one who lived in Bedminster Township for his entire life. He married Eva (Eve) Shellenberger and they had several children. (THRGEN_8 Redir). He died in 1830 without a will, the Letters of Administration document for his estate shows several of his children but I don't know if this list is complete. (THRGEN_13)

The third son was John Weisel b. 1767 who was thought to been lost since he was not mentioned in his father's 1796 will. The reason for this became evident when his trail was found in Bedford County, as the will only mentioned the real estate heirs by name while the heirs to the personal property were grouped but not individually named. John married Sarah Honig [Hoenig?] at Tohickon in 1792. Sarah bore one son, John, b. 4 Apr., 1793 (INTRO_3 ReDir Page 185) before her death. John then married Anna Barbara before removing to Bedford County by 1795 where he joined his Richland Township cousins. He died 10 December, 1844 in Bedford at age 77 leaving an estate and a will. His wife, Barbara, died 14 November, 1857 in Bedford. His 1844 will in Bedford County lists his children.

Our direct ancestor, George Ludwig Weisel was born 11 March, 1773 bp. 20 Jun, 1773 Wit: George Ludwig Seipel and Catherine. He was the fourth son and a boy during the Revolutionary War in which two of his elder brothers, Michael Jr and Henry were militia soldiers. After coming of age, he and Margaret Scheib were married at the Tohickon Reformed Church on 19 April, 1796. (THRGEN_14 Page 414). They had three children, Maria Magdalena, bp 3 Sep., 1797 with Margaret Weissel as witness, John George b. 8 Nov., 1799 bp. 15 Dec., 1799 with George and Elizabeth Scheib as witnesses and Michael, b. 18 Feb., 1802 bp. 25 Apr., [1802], there were no witnesses for the latter. The first two births are recorded at Tohickon Church Reformed (INTRO_3 Page 191), while the birth of Michael is recorded in History of Tohickon Church by William John Hinke.

For Maria Magdalena b. 1776, I found traces of a marriage in the Tohickon Church records but could not definitely identify the woman as our Maria Magdalena. As can be seen, our German speaking ancestors tended to use the same names from one generation to another, making it somewhat difficult to identify specific persons.

This review rounds out the third generation of our ancestral family. I have not included anything beyond the third generation for branches other than our own.

Migrations of the George Ludwig Weisel family started after George married Margaret Scheib on 19 Apr., 1796 at Tohickon. In 1800, they were living in Bedminster Township according to the 1800 U. S. Census (THRGEN_15) where he had inherited land according to the terms of his father's 1796 will. But by 1810, he had moved his family across the County line into Montgomery Township, Montgomery County. (THRGEN_16) This distance was not very far but it would

have been a different governmental unit. In 1820 and in 1830, the family
was still living in Montgomery County probably in a rental property as I was able

was still living in Montgomery County probably in a rental property as I was able to find no record of any land purchase.

By 1840, George and his family had moved back to Bucks County, New Britain

Township. (THURGEN_17) By 1850, George and his wife Margaret Scheib Weisel

were living in Warrington Township, Bucks County along with their son, John

George and his

family (THRGEN_18) This shifting back and forth across counties and townships was a surprise to me as I had thought the Weisels had always lived in Warrington Township.

I, Michael Weissel of Tenicum in the County of Bucks and Commonwealth of Pennsylvania being in a very weak state of body, but of sound mind, memory and understanding, for which I thank God, and considering that all flesh must die, have thought fit to establish this my last will and testament in manner following, that is, I commend my soul to God who gave it, and I desire my body to be buried in a Christian like manner at the discretion of my executors herein named -- and as touching my worldly estate wherewith this pleased God to bless me, my will is, that after payment of my funeral charges and just debts, my dear and loving wife Mary Weissel shall take the case of drawers that stand in the room where I now lay, one bed, four chairs which she shall chose, and such other of my household goods as she shall choose, to the amount of twenty dollars; likewise she shall take any cow she please out of my flock and two sheep, and after she has taken these things out, she shall have one third part of my movable estate and the yearly income or interest of five hundred pounds during her natural life, and at her decease it shall be divided as the other part of my estate, Catherine's bed and such other articles about the house as have been generally called hers, she is to keep and after the above mentioned articles are taken, my will is that as soon as my executors shall think it suitable and convenient, after my decease, that they shall sell all my estate both personal and real, and make a fair and equal division of the amount or proceeds thereof among all my children namely Elizabeth Smith, Magdalena Busy, Eve Shwartz, Michael Weissel, Daniel Weissel, Susanna Shwartz, Catherine Weissel, Tobias Weissel, and Samuel Weissel, each and every one of them to have share and share alike -- and lastly I do make and ordain my sons-in-law Jacob Busy of Tenicum and Nicholas Shwartz of Plumstead executors of this my last will and testament, revoking, disannulling and disallowing and making void all other or former will and testament constituting ordaining and confirming this and no other to be my last will and testament. And further do make or cause to be made a true and just account of their said administration at or before the 18th day of June 1831. The census indicates that it is very likely the two farms were adjoining properties since one entry follows the other.

From the first entry, it seems likely that Henry, the oldest son, had married by this time and left his father's house. Fourth Generation

Maria (Mary) Magdalena was the eldest child of George and Margaret Scheib Weisel. By 1820, she would have been 23 years old and according to the 1820 U.S. Census, it appears that she was now living with her husband, Henry Danehower, Jr. in Gwynedd Township, Montgomery County (FORGEN_1). Henry Danehower Jr. died in 1831. He predeceased his father Henry, Sr leaving his widow with two small children to raise by herself. The older one, George Dannenhauer (Danehower), married Sarah Ann Berkenstock at the Whitpain Reformed Church on 10 Feb., 1842 (THRGEN_14 ReDir Page xx). He and his wife lived in Gwynedd Township where they had one child, a girl named Clementine. (FORGEN_2) She married and there were descendants that were living in the early 1900s (FORGEN_3). The younger son. John Danehower, also married but did not fare as well economically. He had a number of occupations and lived in several locations but I was not able to trace his descendants. He left no record of an estate but that may just mean that he had insufficient assets to require either a will or letters of administration. (FORGEN_4)

John George Weisel, who used his middle name, George, married Catherine Scheib at the Whitpain Reformed Church in Montgomery County on 15 Sept., 1822. (THRGEN_14 ReDir Page 16) It is likely that Margaret and Catherine Scheib were related in some manner but I do not know the relationship. In the 1830 U.S. Census, George and Catherine were living in Montgomery Township, Montgomery County, in the same household as George L. and Margaret Weisel. George and Catherine Weisel had four children who survived to adulthood. They were Henry, b. 21 Sept. 1823 in Montgomery County, Mary Ann, b. 03 Oct., 1825 in Montgomery County, Samuel b. 12 Apr 1828 in Montgomery County and Aaron, b. 25 Feb. 1831, probably in Montgomery County although by the 1840 U.S. Census the extended family had removed to New Britain Township, Bucks County.

The third child, Michael Weisel, never married, he farmed and lived with his father for part of his life and then with his brother, George Weisel.

Commentary: It seem likely that Mary Danehower, having lost her husband, went to live with her son George, who was born about 1820 and would have appeared in the age 0-10 column in the 1820 census. George Danehower was married to Sarah [Ann Berkenstock] and they had one small child, Clementine, age 5.

It appears that Mary Danehower's second son, John, had lost his wife by 1860 and that his mother had gone to live with him in Montgomery Township to keep house and care for her granddaughter.

Samuel Weisel's family bible contains the following entry:

Mary Danehower nee Weisel died February 6, 1868 Aged 70 yrs, 5 mo, 11 days

Samuel's notebook may shed some additional light on this matter. It says: (Mary born 1798) [should be 1797] married Henry Dannenhower. They had two children - Sarah Berkenstock and Elizabeth never married. [This statement is questionable since the 1830 census gives evidence for only one daughter, unless there was another girl born between 1830 and the death of her husband, Henry, in 1831, not possible if a son, John, was born shortly before or after the death of his father. In fact, this whole statement is probably in error since it is contradicted by the above census records. The 1838 will of Henry Danehower, Sr., states that his son Henry (deceased) has two surviving children but it does not name them or indicate whether they are male or female. If John Danehower is a son of Henry Danehower, Jr. and Mary, it would appear that the daughter had died and that George and John are the two surviving children.]

Estate of John Danehower

A search of the Montgomery County records for John Danehower, son of Henry and Maria Magdalena Danehower revealed no record of an estate for either him or Sarah, his wife.

A written request to Bucks County brought a similar response, that such an estate was not open in Bucks County. This would indicate that John Danehower, who moved around quite a bit in his early life, had removed and was not living in either Montgomery and Bucks County by the time of his death.

A similar inquiry to the Bucks County Register of Wills elicited a like response, that there was no record of an estate for a Sarah Danehower in Bucks County.

Fifth Generation

Henry Weisel was the eldest son of George and Catherine. He married Maria Loux (Laux) on 18 Nov. 1847 at the Whitpain Reformed Church. (THRGEN_14 ReDir Page 13) Henry and Maria had several children of whom three survived to adulthood. The 1860 U.S. Census lists them as Lydia, Henry O. (who went by the name of H. Oliver), and Michael Louis. (FIVGEN_1). The 1870 census record shows Henry C. which is either mistaken or my transcription error. By 1880, Henry had removed to New Britain Township and H. Oliver was living on the family farm in Warrington Township. Henry died 3 Jun, 1885, (THRGEN_10 ReDir) at the age of 62. The place of his interment is uncertain, he bought a plot at Hilltown but his wife and other family members are buried in Beulah Cemetery, New Britain Township, Bucks County. He died without a will, Letters of Administration were issued to settle his estate. (FIVGEN_2)

Mary Ann, b. 3 Oct., 1825 was the only daughter of George and Catherine Weisel. She did not marry and died 20 Feb., 1878, aged 52 years. (THRGEN_10 ReDir)

Samuel Weisel, the patriarch of our family, married Catherine Ann Cover (Kober) on 2 Nov. 1851 at the Tohickon Church. (THRGEN_14 Page 439) Samuel and Catherine had six children who survived to adulthood. Children were Franklin Pearce, b. 18 Jan., 1854, Amanda b. 10 Jul., 1855, Mary Ann, b. 24 Aug., 1857, Anna Catherine, b. 20 Sep., 1859, Henry Phares, b. 14 Oct., 1861, who used the name H. Phares and Sarah E. b. abt. 1864. The 1860 U.S. Census shows Samuel living with his parents and his brother, Henry as part of an extended family. By the time of the 1870 U.S. Census, there appeared to be three families (those of Henry, Aaron and Samuel) living side by side in three adjoining farms located along the Pickertown Road in Warrington Township. It appears that Samuel may have been living with his father George. In later years, first Henry, then Aaron moved to New Britain Township. In the 1900 U.S. Census, Samuel continued to reside at his farm with his wife Catherine Weisel. This was probably on the same

property as the home of his son-in-law, William Detweiler who had married Samuels' daughter, Mary Ann. William was first married to Sarah Weisel until her death in childbirth. He then married her sister, Mary Ann. By 1910, he and Catherine were residing with William and Mary Ann in the same household. (FIVGEN_3) This arrangement apparently continued until Katherine died in 1914 and finally Samuel's death in 1916. His 1912 will was handwritten and not witnessed but it was admitted for probate upon petition by the executors named in his will, Frank S. Reiff and William H. Detweiler. (FIVGEN_4) Both of these men were Samuel's son's-in-law. Samuel died on 26 Mat, 1916, he was 88 years of age. He is buried in the Pleasantville Evangelical & Reformed Church cemetery along with his wife, Catherine. Also buried in the same cemetery are his sons Franklin P. Weisel and H. Phares Weisel and their wives. (FIVGEN_5) The reverse side of this page shows the burial place of his grandson, Willis L. Weisel and his family members. Samuel was a well known resident of Warrington Township, a brief biography [annotated by me] describes his life. (FIVGEN_6). A transcription of family records from his bible, dated April 1, 1888 gives some additional information about family members. (FIVGEN_7) A history of the Weisel farms in Warrington township is shown in records of the Bucks County Historical Society Library (FIVGEN_8). Samuel of our line should not be confused with Samuel Weisel, a son of [John] Henry Weisel of Bedminster Township. His biography is shown here for comparison. (FIVGEN_9)

Aaron Weisel b. 25 Feb., 1831 was the youngest son of George and Catherine. He married Maria Cover (Kober) at Tohickon Church on 17 Aug, 1854. (THRGEN_10 ReDir page 441) I know Aaron's family only from the church records and the U.S. Census records. The 1860 U.S. Census lists Aaron and Maria as living in Warrington Township,

along with two small children, Levi age 4 and George W. age 2. By 1870, Levi was apparently deceased and the family consisted of father, mother, George, age 11, John age 9 and Mary age 6. In 1880. George apparently was no longer living at home. There were just John, age 18 and Mary, age 16. I have nothing further on

this family.

This review finishes my brief history of the family of Samuel and Katherine Kober Weisel up through the fifth generation.

Biography of Samuel Weisel

SAMUEL WEISEL, farmer and lumberman, P.O. Chalfont, is of German linage, his great-greatgrandfather [George Michael Weisel] having emigrated from Germany, when 12 years of age [age of immigration is incorrect - George Michael Weisel, the immigrant was married and came to North America with either 6 or 7 children depending on whether Frederick was the eldest son named in the 1757 will]. He [George Michael] settled in Bedminster township, where his son Michael was born [incorrect - son Michael [Sr.] came with the family and in 1732 was about age 12 when they arrived in Philadelphia] and lived until his death [in 1796 at age 76]. His son, George [Ludwig], was the grandfather of our subject. He was born in Bedminster, March 11, 1773, and removed to Montgomery County, where he bought a farm, where he lived until he came [not as direct as this description implies] to the farm now occupied by Samuel, on which he died, April 23, 1862 in his ninetieth year. On April 19, 1796, he was married to Margaret Scheib, who was born June 8, 1775 and died May 27, 1858 in her eighty-third year. Their children were Mary Magdalena, [John] George and Michael, all deceased. [John] George, the father of Samuel was born November 8, 1799, and died February 23, 1881, aged 82. He lived with his father until the latter's death, and in 1833 [the family consisting of three generations] removed from Montgomery County [first to New Britain Township] and then to the place now occupied by his descendants in this township, which he and his brother Michael owned in partnership. Later they dissolved, and George took the entire property, which he deeded to his son Samuel on the latter's marriage. On September 15, 1822 he was married to Catherine, daughter of John Scheib, of New Britain Township, where she was born, August 22, 1802. She is still living with her son, and is now in her eighty-sixth year. To this union four children were born: Henry, born September 21, 1823, and died June 3, 1884? [1885]; Mary Ann, born October 3, 1825, who died February 20, 1878; Aaron, born February 25, 1831, now living in New Britain Township; and Samuel born April 12, 1828. He was five years of age [no, the family was still living in Montgomery County in the 1830 census] when his parents came to this township, and since then has always lived on the same place. On his marriage he took possession of the farm, his parents removing to the new house they had built on the property where his father died, and where Samuel had also removed a few months previously. The farm then comprised sixty-four acres, but subsequent purchases by Mr. Samuel Weisel have increased it to two hundred and seventy-three acres, making him the largest landowner in the township. Seven years ago he gave up active management of the farm to his son, Franklin P., and has since attended to the saw-mill, which adjoins the place. On November 2, 1851, he was married to Catherine A., daughter of John M. Kober, who was born in New Britain Township, September 15, 1829. Their union was blessed with six children: Franklin P., A. Amanda, Mary A., Catherine Ann, Henry Phares, living; and Sallie E., deceased. Mr. Weisel has an interest in educational matters, and for sixteen years has been school director. He and his wife are members of St. Peters's Reformed church at Hilltown, of which he has been a deacon. He is an energetic citizen, whose well-directed labors have entitled him to the competence he is enjoying. In politics he is a Democrat.

Weisel Farm History

In Colonial times there was situated a great plantation of 315 acres owned by a Welsh family named Reese. The lands of this plantation are now subdivided into the families of Adam Martin, Samuel Weisel, and Charles Haldeman and the Selner estate besides a portion belonging to the Larzelere farm. Previous to 1768, there was but one house where now there are eight.

In 1722, Joseph Kirkbridge, a land speculator of colonial times, sold 250 acres to Thomas Reese. In 1729, a contiguous tract of 65 acres was purchased from John Humphrey making 315 acres in all. In 1768 a son, David Reese, began to divide and sell the plantation. Robert Flack in 1768 bought 85 acres. This part was lately included in portions of farms of Henry and Aaron Weisel. In 1773, Reese sold the remainder of 237 1/4 acres to Henry Darrah. James Darrah, a son of Henry, came into possession of 170 acres in 1789 by purchase from his father's estate. This included the present farm of Samuel Weisel and the mill site while his brother, William acquired the Haldeman farm. In 1794 James Darrah moved to Warminster and sold the farm to Michael Moyer. He divided this 170 acres between his two sons, Michael and Abraham, the latter received 91 acres.

George L. Weisel bought of Michael Moyer in 1828. The Weisels are descendants of Geo. Michael Weisel, who emigrated in 1732 from Alsace [Questionable geographic comment]. Three sons [Actually four sons including George] came with him, Michael, Jacob and Frederick. They were redemptioners, or those who having no money to pay their passage, were sold into servitude for a time to pay that debt. Michael settled in Bedminister where he married Mary Trach in 1750 and bought land near Hagersville. His son, Henry served in the Revolutionary Army [Also his son, Michael Jr.] His son George [Ludwig] was born in that township in 1773 and only came to Warrington Township when an elderly man where he lived to be 89 when he died in 1862 and was buried in Hilltown Reformed Church Cemetery. He built a saw mill on his purchase. In 1831 he [George L.] moved to Montgomery County after conveying his lands to his sons, John George and Michael. [Conveyance statement probably not accurate] In 1840, John George became the owner of the whole. Flack conveyed in 1848 his land to John George Weisel. In 1849, Henry Weisel, brother of Samuel and Aaron Weisel became the owner.

Samuel Weisel and Catherine Solliday Weisel

Samuel Weisel, youngest son of Henry and Eve, born August 4, 1804, was a lifelong resident of Bedminster and adjoining parts of Hilltown, and died in Hilltown, August 9, 1889. [Henry was the second son of Michael Weisel, Sr. and an older brother of our ancestor George Ludwig Weisel.] He married, May 24, 1829, Catherine Solliday, born June, 1807, daughter of Peter and Magdalena (Godshalk) Solliday, granddaughter of Jacob and Barbara (Loux) Solliday and great-granddaughter of [Maria] Barbara [Weisel] and Frederick Solliday, who came from Switzerland and settled in Bedminster about 1740. [Barbara Weisel is believed to be the daughter of immigrant [George] Michael Weisel who settled in Bedminster.]

Frederick Sallade (as the name was originally spelled) was a clock maker and armorer, and tradition relates that he rendered efficient service to his adopted country in the trying days of the Revolutionary War in the making and repairing of firearms for the use of patriot soldiers. He settled on a farm purchased of William Allen, near Deep Run Mennonite meeting house, and died there at an advanced age, June 24, 1804. He and his wife Barbara were members of the Tohickon Reformed church, and among the earliest records of baptisms there is that of their son, Jacob, born January 22, 1748.

Peter Solliday, father of Catherine Weisel, was the second son of Jacob and Barbara (Loux) Solliday, was born in Bedminster, Bucks County, September 24, 1783 and died there March 1859. He was also a clock maker, and followed that vocation all his life. He remained on the farm with his father, and in 1813 purchased the horiestead and 150 acres which he conveyed to his son Peter G. Solliday in 1857. He married, October 6, 1805, Magdalena Godschalk, born April 1, 1785 died January 12, 1851 daughter of Michael Godschalk of Bedminster, and they had issue: Jacob, born April 15, 1806, married December 6, 1829 Maria Hartzel; Catherine, born June 1807, married May 24, 1829, Samuel Weisel; Barbara, and others

The children of Samuel and Catherine (Solliday) Weisel are: Magdalena, born June 4, 1830, died young; Francis S., born October 27, 1832, Elevina, born December 17, 1835, wife of David H. Bean of Allentown; Caroline, born December 17, 1835, wife of Levi Shellenberger of Hagersville; Eve, wife of George Swartz, of Souderton; and Mary, wife of Samuel Rotzel of Perkasie.

Francis S. Weisel, now residing in Philadelphia, was the only son of Samuel and Catherine (Solliday) Weisel, and was born in Bedminster, three miles above Dublin, October 27, 1832. On March 30, 1868, his father conveyed to him the farm and hotel in Hilltown, known as the Green Tree Hotel, on the Swamp Road opposite the old Weisel homestead, and he was the proprietor of the hotel for five years. In 1873 he removed to Telford borough, where he owned and conducted a hotel and was the postmaster of Telford for ten years. He then removed to Doylestown and purchased the Railroad House, which he conducted for four years. In 1887 he removed to Philadelphia where he has since lived a quiet and retired life. He was a member of the Reformed church until his removal to Philadelphia, but for the past eighteen years has been a member of the Presbyterian church, he and his family being now members of North Broad Street Presbyterian Church. He married in 1866 Annie E. Bowers, born near Jamison, Warwick Township, Bucks County, August 28, 1847, daughter of Charles and Franey (Veronica) Delp Bowers.

Francis S. and Annie E. (Bowers) Weisel are the parents of two sons: Elmer P. and Oscar W. Weisel; and a daughter, Florence, who died in infancy.
